We must make it clear that NO personal detail was provided about the individual respondents to the survey. Ideally local landowners would come forward to enable site(s) to be considered; currently that is not the case. In the meantime the RCCE (who managed the Housing Needs Survey) advise those seeking affordable housing to register their interest on Colchester Borough's Housing Needs Register.
